United Kingdom, Irish Republic and Scotland

## I. Order Procedure

All orders are accepted subject to our General Conditions of Sale on receipt of your order. No orders will be considered as valid, unless confirmed by e-mail or telefax in writing by Scanpolex ApS. Please check all confirmed orders for accuracy - advising us of any discrepancies. Please quote customer account number on all correspondence.

## Quotations

- All prices are quoted in Sterling, unless otherwise individually agreed.  
- All prices are quoted excl. VAT.  
This will be levied at the current rate.

## II. Conditions of Delivery

- Above mentioned quotations state the prices as 'Free Home' Customers address, unless otherwise individually agreed.
- Our quotations are individually calculated for deliveries to the UK Mainland, Northern Ireland and Irish Republic. Regarding the Scottish Highlands, Channel Islands, Isle of Man, Isle of Wight and the Scilly Islands and any other Isles, please ask for a special quotation.
- All supplies depend entirely upon conditions of the crops. Should any products become unavailable, caused by failures in production or delays, due to reasons beyond our control, Scanpolex ApS reserves the right to cancel your order, or alternatively to substitute with the nearest variety of equal or better standard.
- Delivery is free to most parts of England, Scotland and Wales for orders in excess of 2 Danish Trolleys, unless otherwise agreed. A separate surcharge is applied for all orders below this volume.
- Notwithstanding delivery and the passing of risk, property in and title to the goods shall remain with the seller until the seller has received full payment of the full price of (a) all Goods and/or Services the subject of the contract and (b) all other goods and/or services supplied by the seller to the buyer under any contract whatsoever. Payment of the full price shall include, without limitation, the amount of any interest or other sum payable under the terms of this and all other contracts between the seller and the buyer.

## Cancellations

- We reserve the right to charge for all or part of any order cancelled by our customer:
  1. Within 40 days of agreed delivery date: 50% of the value of goods for the scheduled delivery week.
  2. Within 14 days of agreed delivery date: 100% of the value of goods for the scheduled delivery week.

## Protected Varieties

- Scanpolex ApS emphasizes the fact, that all varieties marked with (P) and (VP) and (PBR App) in our catalogue and on [www.scanpolex.com](http://www.scanpolex.com), are either registered, protected or under Plant Breeder's Rights Application where propagation is not permitted. We draw your attention to the fact, that eventual permission to propagate these varieties is a matter between our customers and the breeders of the protected varieties.

## Labels

- All royalty plants distinguished by (P) and (PBR App) are automatically supplied with a label.

## Royalty

- Royalties are invoiced per plant in Sterling where applicable.

## III. Force Majeure

All supplies depend entirely upon conditions of the crops. Should any products become unavailable, due to failures in production, lack in supply from our suppliers, transport delays or strike action, a civil war, or any other event having a dramatic impact in the supply chain, due to reasons beyond our control, Scanpolex ApS reserves the right to cancel your order, alternatively to substitute with the nearest variety of equal or better standard.

## IV. Complaints

Complaints due to any quality problem or short delivery cannot be considered, unless made within 48 hours of receipt, and in writing within 5 days of receipt. Scanpolex ApS shall incur no other liability in respect of any consequential loss whatsoever arising out of the supply of such products.

## V. Payments

- a) Payment is due 30 days after the date of the invoice, unless other individual conditions have been approved in writing by Scanpolex ApS.
- b) Payment by electronic transfer is preferred. Alternatively, payments via cheque are accepted. When ordering your electronic transfer, please enclose following instructions to your bank, enclosing information stating which invoices the payment is covering.

- d) Scanpolex ApS reserves the right to pass on any increased costs arising from currency fluctuations of more than 10% from the rate prevailing when the order was quoted for.
